Check will be payable to the winner's College, University, or Technical/Vocational School.

If for any reason the applicant is unable to fulfill the Scholarship Rules or the Eligibility Requirements, the Executive Board shall terminate all funding for the recipient.

Applicants should notify the Executive Board Secretary if Applicants College, University, or Technical School changes from the one stated in the application. Failure to comply will terminate all funding to the recipient.

One Letter of Recommendation from a Teacher, Counselor, or Employer

Essay- Format must be typed, 12-point font, double spaced, and at least 3 pages. Select Five of these Seven topics:

- 1. Explain how receiving this scholarship would support your educational and career goals. Be specific about the financial, academic, or personal impact it would have, and how it will help you overcome current obstacles.
- 2. Outline your short- and long-term educational and career goals (for 5, 10, 15, and 20 years). Include specific degrees, certifications, or training you plan to complete, and explain how your interests, experiences, or values influenced these goals.
- 3. Describe how the person who wrote your letter of recommendation has positively influenced your personal, academic, or professional growth. Include specific examples and explain why you felt they were the right person to speak on your behalf.
- 4. List your extracurricular activities (clubs, sports, arts, etc.), including names, years of participation, and average hours per week. Choose one or two activities to describe in detail, focusing on your role, your consistency, and why they were meaningful to you.
- 5. List all leadership roles you've held during grades 9–12. Include your title, the organization, and the year(s) you served. Briefly describe your responsibilities or any impact you made in those roles.
- 6. List all verified community service or volunteer activities, including the organization name, a brief description of your work, total hours served, and dates of service. Highlight any ongoing or meaningful contributions you made.
- 7. Describe a significant challenge you have faced. Explain the steps you took to address it, the outcome, and what you learned from the experience.

Each response should be clearly identifiable within the essay. Use distinct headings, topic sentences, or other clear markers to help evaluators distinguish which prompt is being addressed.

DO NOT include your name and your sponsor's name in your essay.
